

PROGRESSION PATHWAY AGREEMENT

(the "**Institution**")

Dear Sirs

Heriot-Watt University ("HWU")

In recognition of the relationship between the HWU and the Institution and to facilitate progression to HWU MSc Programmes (this refers to entry to the start of the programme):

(A) This Agreement sets out the understanding on which HWU is willing to provide a discount in the form of a fee abatement to students from the Institution (the "**Students**") for on-campus taught masters programmes at HWU, Edinburgh commencing in the Academic Year 2025/26 and thereafter (the "**Programmes**" and each a "**Programme**"). For the avoidance of doubt, students classified as having home fee status (including UK-domiciled students) will be required to pay the full home fee and will not be eligible for the 50% fee abatement.

(B) Except as otherwise stated, this Agreement is not intended to be legally binding or create any contractual relationship between (i) the parties, or (ii) HWU and any Students (or other third parties).

(C) This Agreement is revocable at any time by either party by giving thirty [30] days' email or written notice to the other party.


1. In the event that a student who has recently studied with the Institution (within three years of the date of application to HWU), meets the entry criteria for, successfully applies to, and enrolls on a MSc Programme from HWU, then HWU shall provide the Student with a discount of 50% on the standard MSc Programme fee (the "**Discount**"). The 50% discount will be subject to periodic review, but it is anticipated that a similar level of abatement will continue for future Academic Years. Any changes to the fee abatement will be communicated to the Institution in writing with reasonable notice.
2. HWU grants the Institution a non-exclusive, non-transferrable, royalty-free, revocable right to use the HWU trade mark(s) attached as Annex 1 to this Agreement (the "**HWU Trade Marks**") for inclusion on any marketing materials for the promotion of the HWU MSc Programmes and the Discount. The use of the HWU Trade Marks shall be subject

to HWU's brand guidelines as set out at: <https://www.hw.ac.uk/uk/services/media-services/brand-guidelines.htm> (as updated from time to time). This clause 2 is intended to be legally binding.

3. This Agreement and any dispute or claim arising out of or in connection with it or its subject matter shall be governed by and construed in accordance with Scots law, and the parties irrevocably agree that the Scottish courts shall have exclusive jurisdiction to settle any such dispute or claim. This clause 3 is intended to be legally binding.
